

LEGAL BASIS FOR PARTICIPATION IN THE GIVEAWAY

1.- PROMOTION ORGANIZING COMPANY

The Association Hands with Heart (HwH) domiciled in Rosalia de Castro 25, Barcelona and identified with the number G67279026 organizes the draw ("the Promotion") of international field, to be developed through the Internet, in accordance with provided for in paragraph participation requirements. The purpose of this draw is to increase the number of followers and attract volunteers for future missions.

2.-START DATE AND END DATE

The Promotion will begin on Febraury 16th, 2023, and shall end on February 28th. HwH reserves the right not to proceed with the promotional action if for the reflected date of the beginning of the same one a more than 20 stakeholders. Similarly, HwH will be able to extend the termination of the promotional action for 1 more week, being the new end date on March 7th, 2023 in case a higher number is registered of 20 of participation.

3.- PARTICIPATION REQUIREMENTS AND PROMOTION MECHANICS

Participation requirements shall be as follows:

- Adults who are graduated in Health Sciences may participate.
- Only Participants who hold an Instagram and/or Facebook, account may participate.
- Participants should follow us and like the post.
